Improving our environmental impact

Southern Housing Group is working hard to improve our environmental impact.. We've recently refreshed our approach and strategy in response to the Government's commitment to reach Net Zero by 2050. Everyone has a part to play in this, it is about how we operate as a business so we'll be looking at all aspects of our work. This short summary outlines the key priorities from our full strategy and action plan.


What are we doing now?

We are at the start of this journey. Our first step is to understand our homes and how we can improve their energy performance. This includes looking at their current Energy Performance Certificate (EPC) and Standard Assessment Procedure (SAP).

There is a huge amount to be done before 2050. Over time, we will be developing a schedule of work to improve your homes. You will be kept informed throughout this process. This will include:

- Upgrading the fabric of your home The windows, the roof, anywhere heat escapes from so that it's affordable to heat and you need to use less energy for heating and hot water.
- Changing heating systems From gas boilers to heat pumps for clean heat and energy efficiency.
- Switching contracts to renewable energy This could include solar energy, wind and water energy and other renewable sources.
- Building new homes By 2027 all new homes that we build will be net zero carbon, so that we won't have to adapt homes to make them sustainable later. That means building with sustainable materials, making sure buildings are well-insulated but won't overheat. It means energy comes from heat pumps and that is it renewable.. We want to make sure that everyone we work with contractors and suppliers are using sustainable practices too, like using and wasting less water when we build.
- Getting ready for renewable energy First we need to make sure that homes are well-insulated, dry and secure. Then we want to shift away from gas to energy types which can be produced sustainably, like electricity, air source heat pumps and electricity produced from wind energy. We'll also be providing charging points for electric vehicles over the next few years.
- Getting ready for sustainable operations This means looking at how we work, replacing our fleet of vehicles with ones that run on renewable sources, and making sure that all our suppliers and contractors are doing the same.
- Learning how to be sustainable Educating ourselves, residents and those in our contract and supply chains about sustainability is part of our strategy. We will help people to understand the technology in our homes and how we can live more sustainably, as well as improving our outdoor spaces to encourage biodiversity and improve health and wellbeing.

- By 2050 we will be Net Zero Carbon across all our homes
- By 2030 we will be Net Zero Carbon in our day-to-day business activities


Our pathway to better energy performance in our homes

- By 2035 All our rented homes will have Energy Performance Certificate (EPC) C or better
- By 2030 All our 'fuel poor' households will have Energy Performance Certificate (EPC) C or better
- By 2024 75% of our rented homes will be EPC C or better.



We will take a resident-centred approach based on actual reductions in energy used in your homes and your energy bills.

- 'Keep residents well informed and understand energy efficiency.'


